COOKIE POLICY

I. GENERAL

As **DENGE INVESTMENT HOLDING ANONYMOUS COMPANY** ("**DENGE HOLDING**", "we" or "**Company**"), we may use technologies such as cookies or pixel tags, flash cookies and web beacons that enable the recording and collection of certain data on your computer, mobile phone, tablet and similar devices while accessing our website located at https://dengeholding.com.tr ("Website"), our electronic platforms and the e-mail messages we send to you. In this Cookie Policy ("**Policy**"), the term "cookie" is used to refer to cookies and similar technologies that may be used by **DENGE HOLDING**.

While it is possible to collect personal data of users through cookies, not all data collected through cookies may qualify as personal data.

If the data obtained through cookies qualifies as personal data within the framework of Turkish law, the Policy constitutes an annex to the **Information Text on the Processing of Personal Data**. In this context, we recommend that you also read the **Information Text on the Processing of Personal Data** to learn how your personal data may be processed and how you can exercise your rights in this context.

II. WHAT ARE COOKIES?

Cookies are small pieces of information stored on the computer's hard drive within browsers. They are used to provide visitors with a personalized experience during the use of the visited website and to improve the services offered and to enhance experiences. They can contribute to ease of use while navigating within a website.

III. TYPES OF COOKIES

Cookies can be categorized in terms of duration or the domain name they belong to.

- **1.** If cookies are classified in terms of duration, they are divided into two as "session cookies" and "persistent cookies":
- a) Session cookies: Session cookies are used in each session in which the Website or other applications or environments of the Company are visited and are automatically deleted when the Website or application is exited. The purpose of such cookies is to ensure the continuity and security of the visit.
- **b)** Persistent cookies: Persistent cookies are recorded on the computer or other devices used by the user during access for a fixed period of time and are not automatically deleted when the session or application is closed. Persistent cookies are used when we need to remember who you are in more than one session. The purpose of such cookies is to increase site functionality by providing faster and better service to visitors.
- **2.** If cookies are classified according to the domain they belong to, they are divided into two as related party cookies and third party cookies:
- **a) Related party cookies:** Related party cookies refer to cookies placed on the website by the visited domain and can only be read by this site.

b) Third party cookies: Third party cookies refer to cookies placed by a different visited domain. If people outside the visited domain place cookies on the user's device via the visited domain, a third party cookie is in question.

IV. PURPOSES OF USING COOKIES

As **DENGE HOLDING**, we can benefit from the cookies we use on our websites, platforms and messages for the purposes specified below:

- **1. Operational uses:** We may use cookies deemed necessary for the control and security of our websites, platforms, applications or services. Examples of cookies used for operational purposes include technologies that allow the use of functions on websites, applications and platforms, and cookies used to detect irregular behaviors on these platforms.
- **2. Functional uses:** We may use necessary cookies to facilitate the use of our websites, platforms, applications or services or to customize them for our users. Examples of cookies used for functionality include technologies that allow us to remember user information and preferences.
- **3. Performance-oriented uses:** We may also use necessary cookies to increase and measure the performance of our websites, platforms, applications or services. Examples of cookies used for this purpose include cookies that allow us to understand how users use our websites, applications, platforms and services and analyze user behavior, and technologies that allow us to understand whether the messages we send are interacted with.
- **4. Advertising uses:** We may use related party cookies and third party cookies to deliver advertisements and similar content targeted to users' interests through websites, platforms and applications belonging to the company or third parties. Examples of advertising uses include cookies that measure the effectiveness of advertisements and cookies that show whether a particular advertisement is clicked or how many times the advertisement is viewed.

V. REJECTING AND DELETION OF COOKIES

Most browsers are set to automatically accept cookies by default. However, users can reject or delete cookies at any time by changing their browser settings. The method of changing the settings varies depending on the browser used, and it is necessary to learn from the service provider of the browser used how to disable cookies. In general, you can reject cookies by the following methods:

- (i) Changing the settings of your browser to notify you when you receive a cookie,
- (ii) Disabling existing cookies,
- (iii) Setting your browser to automatically reject cookies.

We would like to point out that if cookies are disabled, you may not be able to benefit from some features of our websites, applications, platforms or services.
